LATE ENTRY

All enrolment forms are due December 1, 2011 and must be accompanied by a \$50 deposit. Please note, a \$20 late entrance fee will apply to all enrolments following December 1, 2011.

REFUND POLICY

- A) Applicants shall be entitled to a refund under the following circumstances:
 - 1. Written notice of withdrawal from the program received prior to 20 December 2011 will incur a cancellation fee of \$ 50.
 - 2. Notices of withdrawal received after 20 December 2011 shall not be eligible for any refund.
 - 3. Total incapacitation due to medical reasons after Dec 20, which is to be supported by a detailed medical certificate, will incur a cancellation fee of \$100, regardless of age (excepting JUNIOR intro to dance students who will incur a cancellation fee of \$50).
 - 4. Should any of the programs be cancelled due to insufficient numbers, students shall be entitled to a full refund.
 - 5. Advanced notice in writing is required for any applications for refunds (except item A3). No refunds will be considered after the completion date of each program.
- B) Fees are non-transferable to another person or deferrable to another date.
- C) Partial refunds shall not be issued for non-attendance.
- D) Non transferable to other training. This applies to holiday workshops and general class fees.
